Dear Mayor and Council Members:

The Taylor Main Street Advisory Board currently has four vacancies at the current time and the potential for an additional four openings at the first of 2006. There are eight applications to consider for filling these vacancies.

Members of the Taylor Main Street Organizational Committee met and reviewed all applications and recommended a telephone interview by the Main Street Manager be done with each. Each applicant was interviewed to 1) ascertain each was still interested in being appointed, 2) could make the time commitment for the required advisory board meetings, 3) is willing to serve on one of the four Main Street Committees, and 4) would be available for board member training.
